ow long are fleets keeping their equipment? This section looks at average fleet size, current age of vehicles, and replacement age of these vehicles. Additionally, it provides a snapshot of total fleet size for all state, county, municipal, and federal fleets, as reported to the federal government.

The most current data available about


state and locally-owned fleets from the Federal Highway Administration shows that fleet numbers for these entities stayed relatively stable from the prior year, showing only a 1.4% increase in total motor vehicles.

Statistics about the federal fleet reveal that for the first time in five years, the federal government in 2011 decreased its fleet size, by 0.35%. The United States Postal Ser-

vice by far has the oldest federally owned fleet on the road, with an average age of 16.3 years, more than double the age of vehicles owned by other federal agencies. E-85 flex-fuel vehicles are the most common types of vehicles purchased in 2011, consisting of 45% of total acquisitions. In comparison, regular gasoline vehicles make up only 38% of total acquisitions.

ROLLING STOCK FLEET SIZE (UNITS)









U.S. FEDERAL FLEET - FY-2011 CENSUS

INVENTORY, COST AND USE SUMMARY

The total federal fleet size in 2011 decreased 0.35% from 2010 totals. while cost decreased by 3.3%. These totals include civilian, military, and postal service numbers and encompass owned, leased, and GSA fleet totals.




COST PER MILE BY YEAR (DOLLARS)

Cost per mile for federal vehicles averaged between 70 cents and 88 cents between 2007 and 2011. These include both foreign and domestic vehicles. with costs for foreign vehicles significantly higher.

Gasoline and diesel vehicles make up 46% of federal vehicle acquisitions for 2011, and E-85 vehicles alone make up 45% of vehicles acquired. The total number of vehicles acquired in 2011 is 54,999 units, down nearly 14% from 2010.

The USPS average fleet age is significantly higher than the ages of vehicles owned by other federal agencies. The oldest federally owned vehicles on the road are the U.S. Postal Services' light-duty trucks, which average 17.3 years in comparison to 5.1 and 7.8 years for civilian and military agencies.

Data shows that maintenance costs for the federal fleet in 2011 are the lowest it has been in five years, down 20% from the prior year. While there were cost increases in some categories, total overall cost is still below 2010 numbers.
